Recently passed a bill that promotes development of ADUs. <u>HB 6107</u> legalizes all ADUs in the state and removes off-street parking requirements. This bill allows ADUs as of right on all properties that contain at least one single-family home. It also lists several restrictions which municipalities are now prohibited from placing on ADU development, including minimum age and occupant relationship requirements.
