## Abstract

## ARTICLE IX. WESTBROOK COMMUNITY FOREST

**DIVISION 1. GENERALLY\***

Sec. 9-151. Purpose.

Establishment of the Westbrook Community Forest will be for the enhancement of forest resources, education on the benefits of preserving tree cover, protection of water supplies, outdoor recreation, environmental education, and the harvesting of forest products.

Sec. 9-152. Location.

A Westbrook Municipal Community Forest is hereby established on a fifty-four and ninety-three-hundredths (54.93) acre parcel owned by the town, having boundaries described on the map entitled "Map of Property of Town of Westbrook, Connecticut" dated April 15, 1992 by Robert L. Doane, Jr., P.E., L.S. Doane Engineering Company.

Sec. 9-153. Management.

The Westbrook Municipal Community Forest, as designated in this article shall be under the management and care of the forest commission. The commission shall take no action which would restrict the town from, at any time in the future, revoking the establishment of said municipal community forest or any part thereof.
